21. SCRUTINY - SPECIAL RESTRICTIONS:
All vehicles must comply with Schedule A and Group 4H of the current CAMS Manual of Motor Sport. Approved helmets in accordance with Schedule D of the current CAMS Manual of Motor Sport are to be worn in **ALL** specials. All apparel shall comply with Schedule D of the current CAMS Manual of Motor Sport. Fuel must be in accordance with Schedule G of the current CAMS Manual of Motor Sport. All cars must be adequately muffled.

22. CLASSES: FWD SPECIALS, RWD SPECIALS, FWD SEDANS, RWD SEDANS
23. PRIZES AND TROPHIES: 1st, 2nd, 3rd Outright
1st in Class (Minimum 3 per Class)
The above awards will be mutually exclusive
Other awards at the discretion of the Clerk of Course
An award will be presented to the fastest Production Renault
24. RESULTS: Results shall be determined by the lowest aggregate of elapsed times on the tests completed, including penalties.
Timing shall be to 0.01 second.
Penalties shall be in accordance with the National Motorkhana Code.
25. The CAMS permit will be displayed at the start of the event.
26. The organisers may refuse any entry in accordance with NCR 83 of the current CAMS Manual of Motor Sport.
27. Entries will be accepted in order of receipt.
28. Entries from competitors under 18 years of age must be countersigned/consented to by a parent/guardian.
29. Certain public, property, professional indemnity and personal accident insurance is provided by CAMS in relation to the event. Further details can be found in the CAMS Insurance Handbook, available at www.cams.com.au.
30. Public Risk Insurance has been effected by the organisers.
31. The organisers may cancel, alter, abandon or postpone the event without assigning a reason in accordance with NCR 59 of the current CAMS Manual of Motor Sport.
32. Protests, if any, must be lodged in accordance with Part XII of the current NCRs.
33. Judges of Fact will be Test Officials.
34. Passengers
This event will include a Motor Sport Passenger Ride Activity (MSPRA) which shall be run under and in accordance with the CAMS MSPRA Policy.
- (a) A briefing must be attended by each Driver and Passenger (and guardians of each Passenger if Passenger is under 18 years of age) conducted by the Clerk of the Course prior to the MSPRA commencing.
 - (b) Passengers MUST:
 - i. wear the same protective gear as a Driver
 - ii. Be fitted and restrained as required for each Automobile with consideration for their physical attributes
 - iii. Complete a Passenger Ride Entry Form and disclaimer
 - iv. Drivers must fill out a Passenger Ride Entry Form to ride as a passenger.
 - v. Be at least 12 years of age
 - (c) Vehicles and apparel used must pass Scrutiny.
 - (d) Vehicles shall only carry one Passenger at a time, unless otherwise approved by CAMS.
35. Any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may be tested for the presence of drugs (or other banned substances) and subject to a penalty(ies) for a breach in accordance with the CAMS Anti-Doping Policy and/or the CAMS Illicit Drugs in Sport (Safety Testing) Policy as published on the CAMS website. Consumption of alcohol in the paddock, pits or any section of the competition venue/course under the control of the Officials is forbidden until all competition is concluded each day. Accordingly, any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may also be tested for the presence of alcohol by a CAMS Accredited Testing Official (CATO) in accordance with the CAMS Standard Operating Procedure for Breath Alcohol Testing.
