All apparel shall comply with Schedule D of the current Motorsport Australia Manual. Fuel must be in accordance with Schedule G of the current Motorsport Australia Manual. All cars must be adequately muffled.

25. **PRIZES AND TROPHIES:**
1st, 2nd, 3rd Outright
1st in Class (Minimum 3 per Class)
The above awards will be mutually exclusive
An award will be presented to the fastest Production Renault
Other awards at the discretion of the Clerk of Course
26. **RESULTS:**
Results shall be determined by the lowest aggregate of elapsed times on the tests completed, including penalties.
Timing shall be to 0.01 second.
Penalties shall be in accordance with the National Motorkhana Standing Regulations.
27. The Motorsport Australia permit will be displayed at the start of the event.
28. The organisers may refuse any entry in accordance with the NCR's of the current Motorsport Australia Manual.
29. Entries will be accepted in order of receipt.
30. Entries from competitors under 18 years of age must be countersigned/consented to by a parent/guardian.
31. The organisers may cancel, alter, abandon or postpone the event without assigning a reason in accordance with the NCR's of the current Motorsport Australia Manual.
32. Protests, if any, must be lodged in accordance with the current NCR's.
33. This Event will include a Motor Sport Passenger Ride Activity (MSPRA) which shall be run under and in accordance with the Motorsport Australia MSPRA Policy.
34. The holder of a Motorsport Australia Licence (or a Licence issued by another ASN) may be tested for the presence of any drug or other banned substance and subject to a penalty for a breach of the Australian National Anti-Doping Policy and/or the Motorsport Australia Illicit Drugs in Sport (Safety Testing) Policy at www.motorsport.org.au.
Consumption of alcohol in the paddock, pits or any other Reserved Area is prohibited until all Competition is concluded each day. The holder of a Motorsport Australia Licence (or a Licence issued by another ASN) may be tested for the presence of alcohol by a Motorsport Australia Accredited Testing Official (CATO) in accordance with the Motorsport Australia Alcohol Policy at www.motorsport.org.au.
